### **General Licencing**

The Aldeburgh Jubilee Hall is a Licenced Premises covered by the 2003 Licencing Act.

Premises Licence PREM0240 dated 22/12/2011, issued by East Suffolk Council, relates specifically to the Hall premises located in Crabbe Street, Aldeburgh, IP15 5BN.

The Premises Licence runs indefinitely from the date of issue.

Details of the Licensing conditions and activities are covered in the Licence document attached.

Outline permitted activities include:

- A/ Performance of a play.
- B/ Performance of live music.
- C/ Performance of dance.
- D/ Playing recorded music.
- E/ An indoor sporting event.
- F/ Entertainment of a similar description to those listed in items B, C & D above.
- G/ The supply of alcohol.

#### **Alcohol Licencing**

Under the requirements of the Licencing Act, in order for the Hall to sell alcohol a Designated Premises Supervisor (DPS) must be appointed and named within the Premises Licence which authorises the sale of alcohol by retail.

The DPS must hold a Personal Licence.

The DPS is the person responsible for the day-to-day management of the premises appointed by the Licence Holder.

The DPS provides the point of contact for the police, fire officers or licencing authority.
